



MILITARY ENTRANCE PROCESSING STATION (MEPS) BRIEFING SHEET

ENSURE YOU BRING THE FOLLOWING ITEMS:

- ___ 1. Picture ID—Driver's License
- ___ 2. Social Security Number Card
- ___ 3. MEPCOM 680a - Request for Examination
- ___ 4. DD Form 2807-2 - Medical Prescreen of Medical History Report
- ___ 5. *DD Form 1966/5 if you are under 18*

Text me when you arrive at the hotel and MEPS.

IMPORTANT INFORMATION:

- a. Closed toe shoes & socks are required; shower shoes or sandals are not allowed.
- b. Clean undergarments are mandatory. You will not be allowed to take a physical without them.
- c. All female applicants must wear bras (no sports bras) and “regular” undergarments. No thongs, “G-strings”, “boy shorts” or see through underwear are allowed.
- d. No shorts, short skirts, or plain white T-shirts. Hats, headbands, sleeveless shirts, net shirts, tank tops, midriff or halter-tops and clothing with objectionable or obscene words or graphics are prohibited.
- e. Piercings of any kind are not allowed and should be removed, regardless if male or female.
- f. Smoking is not allowed at the MEPS.
- g. Headphones may not be worn at the MEPS.
- h. Glasses: Applicants who require corrective lenses should report with glasses rather than contact lenses whenever possible. Note: colored lenses are not acceptable for the color vision test. If you bring contact lenses, ensure you bring the case and solution.

DO NOT BRING:

- a. Valuable items, such as laptops, jewelry, expensive sunglasses or hand held video games. MEPS has locked storage areas for your personal belongings. MEPS personnel are not responsible for loss or damage to your personal property.
- b. Gum or candy
- c. Large amounts of cash. The MEPS will provide you with meals and lodging. A change machine is located in the vending area for your convenience.
- d. Weapons or contraband of any kind (including pocketknives). Individuals entering a federal facility may be searched for contraband. You will not be permitted to enter the MEPS if you have a weapon (even if you have a license of permit to carry the weapon) or any other illegal item with you.

WHEN YOU ARE RELEASED:

After you complete the MEPS processing you will need to call me and provide me with the following information and to arrange a time to drop off your DD Form 2807 (Report of Medical History) and DD Form 2808 (Report of Medical Examination).

- *Color Vision (DD 2808 block 66)*
- *Depth Perception (DD 2808 block 67)*
- *PULHES score (DD 2808 block 74b)*
- *ASVAB score (USMEPCOM PCN 680-3ADP Testing block)*

*****You WILL NOT enlist at MEPS. This is to verify that you are eligible for enlistment into the Air National Guard*****
