The scope of the 39th Airlift Wing (139th AW), Missouri Air National Guard, Environmental Management System (EMS) includes all organizations and facilities located within the boundary of the 139th AW Installation. The installation is a contiguous property of 57 acres owned by the Air Force and 413 leased acres utilized by the Missouri Air National Guard for use by the 139th AW. The EMS applies to all facilities, military personnel and contractors working for or on behalf of the 139th AW.

To meet requirements of EMS ISO 14001 standard an organization of any size or type must:

- identify and control the environmental aspects and impacts of its activities, products or services, and to
- improve its environmental performance continually, and to
- implement a systematic approach to setting environmental objectives and targets, to achieving these and to demonstrating that they have been achieved.
